1 INTRODUCTION

The Rotary Club of Kasangati in conjunction with the Rotary Club of Kisaasi-Kyanja have been mentoring the Rotary Club of Gayaza to formalize and finalize their formation as an independent Rotary Club. The Rotary Club of Gayaza In Formation began its meetings in June 2021. To date the Rotary Club of Gayaza In-Formation (RC Gayaza IF) has selected an interim committee. This committee led the implementation of a service project on the 29th August 2021 in the villages of Mundazabazzadde and Nakwero "A" based in Gayaza – Wakiso district. The service project sought to alleviate the challenges of the COVID-19 pandemic by providing material items to affected households. Twenty one affected households were visited by RC Gayaza IF members.

The service project day also coincided with the 10th edition of the cancer run. Given the restrictions that have been brought about by the COVID-19 regulations, the prospective members of RC Gayaza IF combined the food and material distribution with the 10th edition cancer run. These combined activities were innovative in simultaneously addressing the effects of the cancer epidemic and the COVID-19 pandemic, but also presented an opportunity for members to interact with one another and their community members. To mark the tenth edition, 27 members of RC Gayaza IF gathered at the G-Café in Kyetume to participate in a one-hour session of aerobic activities.

The first case of COVID-19 in Uganda was reported on the 21st March 2020 (UNDP- Uganda 2020). The 32 day lock down that ensued on the 18th March 2020 resulted in a subsequent suspension of mass gatherings. On the 30th March 2020, schools were closed (COVID-19 response hub, 2020). The lock down resulted in a closure of businesses and affected millions of people who were dependent on the informal sector of employment for their livelihoods. 87% of the total employment in Kampala is informal (Uganda Bureau of Statistics (UBOS) which means that residents of Kampala and surrounding districts rely on their daily trade to feed themselves and their families. According to the Development Initiatives report (2020), the pandemic caused a likely increase in poverty as the economy of Uganda slowed down, many people faced a reduction in their income due to job and livelihood losses, reduced flow of remittances, loss of market and loss of demand for domestic products (Development initiatives, 2020). According to GIGA, (2020), the operations of informal businesses declined sharply during lockdown and female owned businesses were hit harder and were uncertain on when to open. These residents also experienced a high risk of COVID -19 infection due to close person to person contact (WHO, 2020). In mid-2021, the Government of Uganda (GoU) instituted a second lock down (of 42 days) to curb the second wave of COVID-19.

1.1 OBJECTIVE

The objective of the exercise was to provide material support to 21 residents of Nakwero "A" and Mundazabazadde villages, based in Wakiso district which have been severely affected by the COVID-19 pandemic.



2 METHODOLOGY

2.1 PREPARATION

The exercise began with the interaction with the local authorities on the 1st August 2021. The Local Council 1 of Mundazabazzadde, Mr Kaggwa Elsa (+256772464939/+256702464939) and Nakwero "A" Mr Patrick Ssemakula (+256701432414/+256776926252) and the Secretary Mr Francis Mawanda (+256787881799) were visited by a select team of RC Gayaza IF Interim committee members. The local authorities welcomed support to be provided to the residents in their villages and reported that they would identify poor and vulnerable households such as elderly women and men, single mothers, households with handicapped children and residents who had lost their employment due to the on going pandemic.

The time line to execute the entire task was given by the local authorities as follows: within two weeks (9th August 2021) the local authorities would conduct a needs assessment and provide a list of 10 households per village to the interim committee. On the 23rd August, a preliminary visit would be made to these homes to finalize the needs assessment exercise. On the 29th August 2021, the food and material distribution would be made.

The names of the vulnerable homes are seen in Table 1. The majority of households that received the food items were women. A total of 143 members belonging to 21 households benefited from the exercise. The distributed items included 2 Kg sugar, 2 bars of Soap, 2 sachets of Salt, Matches, 3 Kg Beans, 2 Kg Rice and 10 Kg Maize Meal. The food and material distribution was flagged off by the Secretary of Nakwero "A" see

2.2 CHALLENGES REPORTED BY HOUSEHOLDS

The households that were visited outlined various challenges. These challenges included:

- Loss of income due to closure of schools, imprisonment of husband for 4 years, or due to illness of the family bread winner.
- Lack of permanent homes. For example, an elderly man called Pascal Ndayisenga lived in a small house and slept on the bare ground but also required medication. See <u>https://www.dropbox.com/s/mlu5lto4lup0c99/VID-20210908-WA0021.mp4?dl=0</u> for Mr Pascal Ndayisenga's living conditions
- People living with HIV/AIDs
- The elderly looking after numerous grandchildren using support (remittances) provided by children. For example, widow looking after 4 grandchildren whose daughter passed on, and another home that had 19 children.
- Two homes were visited where the residents lived with disabled children. In each case, the disabled child was estimated to be 15 years. In one case, the disabled child could not do anything for themselves. In the second case, the home also had many other children.
- Homes with widows, or members who were unwell and so did not have a source of income
- Homes with single elderly women who had a limited source of income such as collecting of plastic bottles.

2.3 FOOD AND MATERIAL DISTRIBUTION IN PICTURES NAKWERO "A"

Food and material items were distributed to 11 homes in the village of Nakwero "A", Kimwanyi ward, Kira division, in Kira municipality. Of the 11 household's food and material support was given to, 9 were women led households with a total of over 60 members in these households.







2.4 FOOD AND MATERIAL DISTRIBUTION IN PICTURES MUNDAZABAZADDE

Food and material items were distributed to 10 homes in the village of Mundazabazadde, based in Kabubbu parish found in Kasangati town council. Of the ten homes, material support was distributed to, 9 homes were vulnerable women with a total of over 60 household members.

3 ROTARY CLUB CANCER RUN 10TH EDITION

3.1 ROTARY CLUB OF GAYAZA IN FORMATION CANCER RUN ACTIVITIES

The day of the cancer run began with aerobic exercise activities that were led by Mr Abdulah Nsereko, a coach from G-Fit fitness club. The aerobic exercise lasted for a period of 1 hour after which breakfast was served. The pictures of the aerobic exercise are seen in section 3.2. In 2021, each cancer run kit cost UgX 25,000. 45 prospective members of RC Gayaza IF secured a kit hence RC Gayaza IF raised 1,125,000 Uganda shillings towards the 10th edition of the cancer run. Twenty seven members attended the aerobic exercises and of these 5 were minors and 17 were females (See Annex 1).

At the Uganda cancer Institute, almost 80% of the patients present the disease in advanced stages hence there is limited intervention to prolong the survival. According to the 2018 Globosan statistics, on cancer in Uganda compiled by the World Health Organization, 32,617 new cancer cases were recorded and 18, 068 were female.

The Uganda Rotary Cancer run Program (UCRP) began in 2012 as a major fund raising vehicle of the Uganda Rotary Cancer program. The fund raising aims to :

- Develop infrastructure for cancer management, For example, construction of hospitals, wards and equipment
- Offering cancer screening and treatment services by building a cancer ward that provides specialists and treatment
- Building human resource capacity for cancer management.

According to Kawowo sports (2021), the achievements to date for the UCRP are a fully operational and equipped 36 bed cancer treatment centre in Nsambya hospital worth about 1.5 Billion Uganda Shillings.


